### Minutes:

The minutes from the April meeting will stand as approved.

### **February Financial Highlights**

Druh Gregg presented the financial position for March 2022 and Q1 overall. An in depth presentation will be done at the Board Meeting this coming weekend, as such, high level analysis was presented.

### **Balance Sheet**

• As of 3/31/22, PFA's assets amount to \$40.78M and liabilities totaled \$39.45M with approx. surplus of \$1.32M

### **Summary of Operations**

- Due to significant annuity cash outflows in March total revenue totaled \$(336,694) due to a \$1M decrease in the reinsurance reserve credit. Q1 2022 revenue totaled \$754k vs prior year of \$1.33M; difference was driven by the aforementioned reserve credit fluctuation.
- Again, due to significant annuity cash outflows overall reserves decreased significant skewing total expenses to \$(257,183) for March 2022. Q1 2022 expenses totaled \$807k vs. prior year of \$1.39M due to the fluctuation in reserves.
- Net loss for March totaled \$(83,715); YTD net loss totals \$(53,501).

- Surplus adjustments for 2022 total \$(45,119) vs prior year of \$(62,361); YTD loss in surplus totals \$(98,620) vs. PYTD of \$(118,088).
- Surplus as of 3/31/22 totaled \$1,327,028.

### **New Sales Processes:**

Sales Director, Jared Gostanzcik reviewed oour processes and felt that a few were bulky. He has contacted several companies and will present a full report to the entire Board at the upcoming meeting.

## **District I and the Liquor License:**

There are two very interested parties in the license. Hillsborough is also making another license available. Druh Gregg will meet with District I President, Elizabeth Laskowski. Hoping to get a resolution with funds going to the District as well as each of the District I Nests.

There is concern regarding the status of District I.

Druh Federowicz reminded us that this is a valuable asset and we need to find a way to appease all parties involved.

This discussion will continue with the entire Board.

# National Bowling Tournament-2022:

Nest 45, St. Louis did a fabulous job hosting the bowling tournament. While there were only 31 teams attending, all had a great time. The bowlers were very happy to be together again. It was impressive that with so few participants, the Nest collected \$760.00 for their charity.
