Scholarship Committee Report

National First Vice President Trish DelBusse announced the winners of the Richard C. Gorecki Scholarship Awards for the 2023-24 school year. The three recipients are Sheena Landy, Nest 519, Middletown, Conn.; Dorothy Kalinowski, Nest 176, Lawrenceville, Pa.; and Victoria Florczak, Nest 6, Buffalo, N.Y.

Financial Report

Ryan Gregg, National Secretary/Treasurer and CFO presented the financial report for the year ending December 31, 2022. The net gain to surplus at the end of the year was \$1,425,648. Total surplus is \$2,973,495. The net loss from operations at the end of the year was \$345,421.

2024 Nominations Committee

The Board of Directors selected members of the Nominations Committee for the 2024 National Convention. Committee members are Tom Washington, Tom Eckert, Patty Capozoli, Becky Sienkiewicz and Chuck Johns. The Board also voted Druhna Capozoli as Chairperson of the Committee. The Committee will establish qualifications for National

Directors, Board Chairperson and Vice Chairperson, which will be approved by the Board. The qualifications will be published in the late summer.

Sales/Marketing

Sales Director Jared Gostanczik and Secretary/Treasurer Ryan Gregg reported on the progress of the new systems and processes for the sale of life insurance and annuities. The online process for the Final Expense Plan is now available. Whole life, Term and Annuities will be added in the summer.

Sales results for 2022: There were 55 life insurance certificates issued, and 104 annuity certificates issued. Total certificates issued 2022 was 159. Also, there were 26 Fraternal Benefit Members added in the year. The average face amount of insurance for the new life certificates for the entire year was \$19,138.

Certificates Report

President Kuzma reported at the end of 2022, there were 17,842 life insurance certificates, 3,217 annuity certificates and 105 Medicare supplement certificates in force. For the year, there was a decline of 550 total certificates. (Life decreased 474, annuities decreased by 50 and Medicare supplement decreased by 26.) There are currently 77 Fraternal Benefit Members, a gain of 13 in 2022.

2023 Youth Programs

National Physical Education Director Puskar presented a report on the recent successful Bowling, Curling, Volleyball event that was held in Pittsburgh, Pa., in April. More than 30 Falcon Members of all ages participated in the program. She also reported on plans for the upcoming Youth Camp that will be held in July. A New Fraternal Program

Second Vice President Dan Michalak presented a proposal for a new Awards program for 2023 to recognize Member Families for the work they do for their Nest or District. The Board approved the program and announcements will be made as soon as possible regarding the details of the program, rules, deadlines, etc.

Falconette Commission

Falconette Commission Chairperson Patricia Capozoli reported that the May raffle is ongoing. Donations for the Bowling/Curling/Volleyball Family Weekend included socks, beanies, seat cushions and \$3,500 for a total of \$5,104.33. Final totals for the May raffle will be reported at the August board meeting.

New Legion of Honor Program

The Board voted to approve a new program for the Legion of Honor. Called "Beyond the Gold," this new program is being created to recognize those Gold Legion of Honor recipients who continue to work for the PFA well after receiving their Gold medal.
